EXPLANATION:

CCCS has contracted with YuJa Corporation since May 2018 for video capture, storage, streaming, and captioning in order to enhance student learning and ensure compliance with accessibility and FERPA standards. The existing YuJa contract expires June 2023. The System completed a Request for Proposal (RFP) solicitation this spring for video storing, capturing, streaming, editing and captioning for students and faculty usage online or face-to-face. Following a comprehensive process, the RFP committee, with representatives from across the System, again selected YuJa Corporation.
