Colorado's 74th General Assembly convened for the legislative session on Monday, January 9th and is on track to adjourn on Monday, May 8th.

Prior to the May meeting, a final end-of-session (Sine Die) report will be completed and provided to the Board.

At the time of this writing, April 24th, the General Assembly has introduced 663 bills and CCCS is monitoring 58 bills. The table below lists bills that CCCS is currently tracking.
