## **EXECUTIVE SUMMARY**

Recommendation that the Broward College District Board of Trustees authorize a standard agreement (purchase order) with QM Quality Matters, Inc. for membership renewal and dues for Broward College Online. Fiscal Impact: \$1,275.00

What is the purpose of this contract and why is it needed? Affiliation with Quality Matters (QM) is an industry benchmark in online higher education. Additionally, this affiliation provides the college with access to statewide quality assurance networks and, importantly, the QM Rubric. The rubric is updated on a routine basis and provides evidence-based standards against which we are able to effectively measure the quality of elearning courses. As an institutional affiliate, Broward College reaps the benefits of research-driven professional development workshops, exclusive review standards, and up-to-date information regarding quality assurance and student success drivers across multiple modalities.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida Statute 119.01(3) requires that all financial, business, and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statute 119.07.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes.

What fund, cost center and line item(s) were used? CC0322 FD109 GLC: 64502:Inst. Memberships and Sponsorships.

Has Broward College used this vendor before for these products or services? Yes.

Was the product or service acceptable in the past? Yes.

Was there a return on investment anticipated when entering this contract? Yes.

Was that return on investment not met, met, or exceeded and how? Yes, Broward College models its Quality Standards in e-Learning rubric against the QM Rubric 7th Edition, which allows us to ensure the quality of course design and delivery in multiple modalities. Additionally, faculty and staff are able to take advantage of QM's ongoing professional development workshops and quality assurance networks to remain up-to-date on evidence-based practices in e-learning. Through participation in Quality Matters, the college joins over 1,300 state and national higher education institutions committed to student success through engaging distance learning opportunities.
