Recommendation that the Broward College District Board of Trustees authorize a standard agreement (purchase order) with the FLORIDA ASSOCIATION OF PUBLIC PROCUREMENT OFFICIALS (FAPPO) for membership renewal and dues for FY2024-2025 for the Procurement department. Fiscal Impact: \$275.00

What is the purpose of this contract and why is it needed? The Florida Association of Public Procurement Officials, Inc. ("FAPPO"), established in 1968, has been focused on and driven towards education, professional development, and agency collaboration and cooperation through networking. FAPPO strives to provide its members with opportunities to advance their public procurement expertise in order to convey current best practices, industry standards, and professional services to their agencies.

FAPPO has a membership of around 1,000 public procurement professionals represented by over 300 agencies throughout the State of Florida, including municipalities, counties, state, special districts and authorities, universities, colleges, school boards, public utilities and sheriff offices. The membership provides its own resource of knowledge, experience, and expertise regarding the ins and outs of public procurement and a huge source of information to the members. Access to these resources and sources of information through FAPPO provides a helpful tool for the Procurement department staff.

Procurement is requesting to renew the membership for FY2024-2024 for its current procurement staff, which includes 2 managers, 1 procurement officer and 3 buyers.

What procurement process or bid waiver was used and why?

Small purchase for Category One (\$0.00-\$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida Statue 119.01(3) requires that all financial, business and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statue 119.07.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes.

What fund, cost center and line item(s) were used?

FD100, CC0229, GLC:64502: Inst. Memberships and Sponsorships.

Has Broward College used this vendor before for these products or services? Yes.

Was the product or service acceptable in the past? Yes.

Was there a return on investment anticipated when entering this contract? The ROI is the access to a valuable source of information for the procurement staff.
