#### 9.1. CEO Update (Presenter - Shane Strum, President, Chief Executive Officer)

Mr. Strum introduced Dr. Daniel Gologorsky, MBA, Ophthalmology. Dr. Gologorsky thanked the District for the state-of-art equipment that allows patients to return to work quickly after eye examinations with reduced time of blurred vision.

Ashley Boxer, VP, External Affairs, Dr. Ana Calderon Randazzo, Children's Diagnostic & Treatment Center (CDTC) Executive Director, and Jessica Vones, CDTC Director, Development, presented Jared Smith, Broward Health Coral Springs CEO, with Man of Style recognition plaque for CDTC fundraising efforts of \$103K, which 100% of proceeds will benefit CDTC. Mr. Smith stated that it was an honor & privilege to represent CDTC.

Mr. Strum presented the full monthly report, highlighting the five pillars (Quality, Service, People, Growth, and Finance) of the organization and the progress at each of the facilities.

The video featured the team of CDTC, Reality Star, Captain Lee and several volunteers hosting the 29<sup>th</sup> Annual Thanksgiving Basket Brigade. This year, CDTC partnered with Amazon.com to surprise families in need with holiday meals and gifts.

- Broward Health Maternity Place

The video featured Broward Health's Maternity Place, which provides award-winning maternity services with all the comforts of home.

Mr. Stum noted Broward Health was (1) of (12) healthcare systems in the nation to be awarded with a one-year \$45K grant from America's Essential Hospitals and the CVS Health Foundation to address improving obstetric care for Black Maternity Patients.

Broward Health's program, called "Every Mom, Every Baby," will focus on educating more than 300 clinicians on how to provide patient-centered care that is responsive to the needs of Black Women.
