#### 7.1.2. Readmissions Reduction Program

Mr. Gallison reviewed the District's Centers for Medicare & Medicaid Services (CMS) Readmissions Reduction Program (RRP) for FY'22 and FY'23 penalty; and the FY'24 estimated penalty of the 3% Centers for Medicare & Medicaid Services withheld.

- All Cause 30-Day Readmission Rate
- Acute Myocardial Infarction (AMI) Readmission Rate
- Congestive Heart Failure (CHF) 30-Day Readmission Rate
- Chronic Obstructive Pulmonary Disease (COPD) 30-Day Readmission Rate

Additionally, provided an overview of the Readmissions Action Plan, including, but not limited, to the following:

- Discharge Process
- High Risk Readmissions
- Transition of Care
