# Background

- ❑ Operational Site Visit (May 2019) determined a number of findings.
  - a) The Program failed to meet 93 program requirements.
  - b) Findings were severe, resulting in subsequent One (1) Year Project Period in FY 2022
  - c) The Health Center Program faced lost of funding and additional oversight by HRSA.
  - d) Most Findings (83) were corrected by delivery of the follow-up consultant report (March 2020).

# Background

## ❑ Federally Qualified Health Center

- a) The Co-Applicant Board was seated on October 28, 2021.
- b) Outstanding Health Center Program requirements were met:
- c) The Co-Applicant Board comprised of 51% or more consumers
- d) Responsible for Governance of Health Center Operations
- e) Calendar of Monthly Meetings established and Publicly Noticed
- f) Department of Learning and Development conducting Strategic Planning and Board Development

# Virtual Operational Site Visit (August 31, 2022, to September 2, 2022)

## ☐ Operational Site Visit

- a) Required Every 3 Years or more based on performance
- b) Broward HealthPoint was notified of an upcoming Operational Site Visit (July 13, 2022) to be held during the month of August 2022
- c) The three (3) day site visit would be held August 30, 2022, to September 2022
- d) This would be a high stakes Operation Site Visit for Broward HealthPoint

# Virtual Operational Site Visits

## Findings and Observations

### ❑ Context and High Stakes for Broward Health Points

- a) High Stakes Visits One (1) Year Project Period and potential loss of Health Center Program
- b) More than 274 Operational Sites held nationally
- c) There were an average of 2,700 findings cites for Health Center Program
- d) Health Center Programs averaged 10 or more findings each
