

2021 Erie Land Bank Work Plan

Blighted Property List

There are currently 140 properties declared 'blighted' by the City of Erie Blighted Property Review Committee. These properties have exhausted the efforts of City Code Enforcement and are typically vacant and/or abandoned, without any utility services, with no efforts being made to mitigate the conditions of blight. 22 of these are under some level of intervention by the owner in coordination with the code enforcement office and the Erie Redevelopment Authority. Several others are being privately rehabilitated without any further public intervention.

Work Plan Development

Work Plan I involved 19 properties through scattered prioritization of blighted properties based on factors identified by code enforcement and the BPRC process. Development of Work Plan II began with a focus on clustering activities based on the priorities of *Erie Refocused*. A total of 22 properties were identified for acquisition, evaluation, and disposition.

Both Work Plan I and II provided a tremendous amount of momentum in the neighborhoods where properties were addressed. These work plans have allowed for 35 properties to be demolished and 6 properties to be offered for rehabilitation. Without this level of blight mitigation these properties would have fallen into further disrepair and lead to a continue decline in the neighborhoods. The vacant lots are being marketed as side lots to adjoining property owners. As of March 2021, 18 properties have been sold or are under a sales agreement.

The proposed 2021 Work Plan was put together to build off this momentum and continue to work toward neighborhood strengthening and stabilization. In collaboration with the City of Erie Planning Department and Code Enforcement properties from the blighted properties list were prioritized. This prioritization was based on numerous factors (including location, ownership tenure, tax status, condition of adjoining properties, neighborhood/code enforcement priorities, etc.). This process has led to the identification of the proposed list of blighted properties within the City of Erie.
